

One (1) pair of ladies Tanzanite and diamond earrings. These earrings are crafted in 14k white gold and feature pierced posts with friction back findings. Each earring consists of an upper diamond "stud" type design of (1) round Brilliant Cut diamond set into a 3-prong setting, with (1) trillion Tanzanite stone prong set in a drop below the upper diamond.

- The (2) diamonds are estimated to weigh an average of 0.25ct. each (4.15mm), for a total weight approximating 0.50ct. The diamonds are well-matched, being SI1 clarity, I-J color.
- The (2) Tanzanite stones are estimated to weigh as follows:
 - 1 @ 2.15ct. (8mm x 8mm x 5.58mm)
 - 1 @ 1.56ct. (8mm x 8mm x 4.03mm)

The total weight of the Tanzanite stones approximates. They are violetish Blue in color with medium dark tone and moderate saturation. GIA Type 1 clarity "eye clean". Using principles as defined in The Guide, these stones are graded as "6"

The earrings have an estimated overall gem weight of 4.21ct. and combined gem and metal weight of 3.0 grams.

The (2) diamonds are valued @ \$618.00 each = \$1,236.00
The 2.15ct. Tanzanite is valued @ \$760.00 per carat = \$1,634.00
The 1.56ct. Tanzanite is valued @ \$650.00 per carat = \$1,014.00
The 14k white gold earring mountings are valued @ \$300.00
