


What You Should Know If you are a Victim of a Crime or Witness to a Crime





As a citizen of Cumberland County, you are entitled to the following:

- To be advised if an arrest is made.
- To be kept informed of the status of your case.
- To be advised about the status of the defendant.
- To be advised about all aspects of your participation in a trial.
- To have any recovered stolen property returned to you as soon as possible.
- To be advised about the results of a trial or any other disposition of the case.

- ▶ If you are injured, you may be eligible for compensation through NC Victims Compensation.
 - ▶ If appropriate, we will contact your employer to discuss the importance of your role in the prosecution of your case.
 - ▶ If you are threatened or harassed, you are entitled to protection as provided by law, including special penalties for such behavior included in the Federal Act cited.

Civil Domestic Violence Protective/Restraining Orders or Civil No-Contact Protective Orders

The SAFE-LINK Domestic Violence Assistance Program was created as a & location for victims of domestic violence, sexual assault and stalking who come to the Cumberland County court system to obtain a civil domestic violence protective/restraining order or a civil no-contact protective order. The program is designed to provide immediate access to our court system to ensure the safety of these victims. In the SAFE-LINK Office, victims have privacy to complete required forms, obtain information about available resources such as community-based programs and shelters, and referrals to immediate services and counselors. Bilingual services are provided and documentation of physical abuse through digital photography is available.

ELECTRONIC FILING FOR 50-B DOMESTIC VIOLENCE PROTECTIVE ORDERS

Did you know that you can file your 50-B Civil Domestic Violence Order lawsuit and process your emergency request without coming to the Cumberland County Courthouse?

Victims can complete and file an order of protection and have their case heard before a judge via video-conference at all four locations. Electronic filing for domestic violence protective orders offers victims a safe and confidential environment outside of the courthouse to file for a protective order with the assistance of a trained advocate. Offering this option provides victims the opportunity to have immediate access to the full continuum of additional services such as counseling, safety planning, shelter, legal referrals and case management.

What is the difference between a 50B Protective Order and a 50C No Contact Order?

50B Domestic Violence Protective Order

In order to file for a DVPO against the abuser, you must have a “personal relationship” with the abuser. North Carolina law defines only certain categories of relationships as meeting the definition of a “personal relationship” for the purpose of being able to file a DVPO. You can file for this type of protective order if you and the person you are filing against are:

- Current or former spouses
- Persons of the opposite sex who currently live together or have lived together in a domestic relationship
- Your child, a parent, a grandchild or grandparent
- Have a child in common
- Current or former household members
- Persons of the opposite sex who are currently dating or have been in a dating relationship

50C No Contact Order

A Civil No-Contact Order (commonly referred to as a “50C order”) is designed specifically for victims of sexual assault or stalking who do NOT have a “personal relationship” with the offender. You can file for this type of restraining order if you and the person you are filing against have any other relationship not listed under the 50B Domestic Violence Protective Order criteria or the person is unknown to you.

In addition to NOT having a personal relationship with the offender, you must have been the victim of “unlawful conduct.” North Carolina defines “unlawful conduct” as:

“The commission of one or more of the following acts by a person 16 years of age or older upon a person, but does not include acts of self-defense or defense of others.” The acts included are nonconsensual sexual conduct, even if there was only one incident, and stalking. Stalking is defined as “on more than one occasion, following or otherwise harassing... another person without legal purpose with the intent to” either “place the person in reasonable fear either for the person’s safety or the safety of the person’s immediate family or close personal associates” or “cause that person to suffer substantial emotional distress by placing that person in fear of death, bodily injury, or continued harassment and that in fact causes that person substantial emotional distress.”
